QUIT CLAIM ASSIGNMENT

THIS QUIT CLAIM ASSIGNMENT, made this 2nd day of December, 2009, by the Estate of Arthur L. VELLUTATO, Sr. (deceased) (hereinafter referred to as "Assignor");

WHEREAS, Assignor may have certain right, title and interest in a METHOD OF STERILIZATION, set forth in U.S. Patent No. 6,123,900, issued on September 26, 2000; U.S. Patent No. 6,333,006, issued on December 25, 2001; U.S. Patent No. 6,607,695, issued on August 19, 2003; and U.S. Patent Application No. 90/009,290, filed on October 1, 2008, all titled METHOD OF STERILIZATION, and in and to any Letters Patent of the United States to be obtained therefore and thereon (the "Assigned Intellectual Property");

NOW, THEREFORE, for good and sufficient consideration, the receipt of which is hereby acknowledged, Assignor has assigned, transferred and set over, and by these presents does assign, transfer, release, set over and quit claim, unto Assignee, its successors, assigns, designees, nominees and other legal representatives, any and all right, title and interest, if any, in and to the Assigned Intellectual Property, and in and to any and all direct and indirect divisions, continuations and continuations-in-part of said Assigned Intellectual Property, and any and all Letters Patent in the United States and all foreign countries which may be granted therefor and thereon, and reissues, reexaminations and extensions of said Letters Patent, and all rights under the International Convention for the Protection of Industrial Property, the same to be held and enjoyed by Assignee, for its own use and benefit and the use and benefit of its successors, legal representatives and assigns, to the full end of the term or terms for which

Letters Patent may be granted and/or extended, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made, together with (i) all causes of action (in law or equity) claims, demands and any other rights for, or arising from, any past, present or future infringement, of the Assigned Intellectual Property, and (ii) the right to sue for and collect any damages for the use and benefit of Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives.

AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, its successors, assigns, designees, nominees and other legal representatives, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patent and applications for Letters Patent for said Assigned Intellectual Property, without charge to Assignee, its successors, assigns, designees, nominees and other legal representatives, whenever counsel of Assignee, or counsel of its successors, assigns, designees, nominees and other legal representatives, shall advise: that any proceeding in connection with said Assigned Intellectual Property, or any proceeding in connection with any Letters Patent or applications for Letters Patent for said Assigned Intellectual Property in any country, including but not limited to interference proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.

AND Assignor hereby requests the Commissioner of Patent and Trademarks to issue said Letters Patent of the United States to Assignee, as Assignee of said Assigned Intellectual Property and the Letters Patent to be issued thereon, for the use and benefit of Assignee, its successors, assigns, designees, nominees and other legal representatives.
