And I hereby authorize Simage Oy to file patent application in any or all countries on any or all of said invention in my name or in the name of Simage Oy, or otherwise as Simage Oy may deem advisable, under any International Convention or otherwise.



And I further covenant and agree, in consideration of the premises, that I, my executors and administrators will at any time, upon request, communication to Simage Oy, its successors and assigns, any facts relating to the invention and the improvements contained therein and the history thereof, known to me or my executors and administrators, and that I will testify as to the same in any interference or other litigation when requested so to do by Simage Oy, its successors and assigns.
