TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT, dated as of December 4, 2009 by **THE CIT GROUP/BUSINESS CREDIT, INC.**, in its capacity as Agent (the "Agent") in connection with the Loan and Security Agreement, dated as of December 4, 2009 (as amended, modified, supplemented or amended and restated and in effect from time to time, the "Loan Agreement") by and among Kolmar Labs Group, LLC (formerly known as Outsourcing Services Group, LLC), a Delaware limited liability company (the "Parent"), Acupac Packaging, Inc., a New Jersey corporation ("Acupac"), Kolmar Laboratories, Inc., a Delaware corporation ("Kolmar" and together with Acupac, the "Borrowers" and each, individually, a "Borrower"), the financial institutions from time to time party thereto (the "Lenders") and the Agent.

WHEREAS, the Parent, the Borrowers and the other Grantors party thereto and the Agent entered into that certain Patent Security Agreement dated as of November 30, 2007 (the "Patent Security Agreement") which Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel 020243, Frame 0415 on December 13, 2007 for the purpose of securing payment and performance of the Obligations (as defined in the Loan Agreement) of the Borrowers;


WHEREAS, pursuant to the Patent Security Agreement, the Grantors granted, assigned and pledged to the Agent, for the benefit of the Lenders and the Agent, by way of collateral security, all of the Patent Collateral (as defined in the Patent Security Agreement) as security for the Obligations;

WHEREAS, the Agent has agreed to terminate and release the Patent Collateral and assign and transfer to the Assignor all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to re-vest in the Assignor the entire right, title and interest to the Patent Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Patent Security Agreement and assigns and transfers to the Grantors, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Patent Collateral, including, without limitation, the patents listed on Exhibit A attached hereto, effective as of the date set forth above.
