ASSIGNMENT OF DESIGN AND PATENT RIGHTS THERETO

WHEREAS, I, Jeffrey Miller ("Co-Assignor"), residing at 10 West End #24A, New York, New York, 10023, U.S.A. and a citizen of the United States of America, and **WHEREAS, I,** Yoshihisa Konishi ("Co-Assignor"), residing at 33 W. Pamrapo Court, Glen Rock, New Jersey 07452, U.S.A. and a citizen of Japan, have invented an ornamental design disclosed in an application for United States Letters Patent entitled Seat with an application number of 29/343,109 and executed by us on September 8, 2009;

AND WHEREAS, Itoki Design Corporation (hereafter, together with any legal representatives, successors, and assigns, "the Assignee"), a New York corporation, having a principal place of business at 147 W. 35th Street, Suite 1505, New York, New York, 10001, wants to acquire the entire right and title to said design and any and all Letters Patent of the United States which may be obtained therefor;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration in hand, the receipt of which is hereby acknowledged, we have sold assigned, transferred and set over, and do hereby sell, assign, transfer and set over to Assignee, the entire right, title and interest to said design, and said application and all divisions and continuations thereof, and all United States letters patents which may be granted thereon and all reissues, reexaminations and extensions thereof, and all priority rights under all available International Agreements, Treaties and Conventions for the protection of Intellectual Property in its various forms in every participating country, and all applications for patents (including related rights such as utility model registrations, inventor's certificates and the like) heretofore or hereafter filed for said design in any foreign countries and all patents (including all continuations, divisions, extensions, renewals, substitutes and reissues thereof) granted for said design in any foreign countries; and I hereby authorize and request the Commissioner of Patents and Trademarks to issue any Letter Patent of the United States which may be issued for said design in the name of the Assignee as the owner of the entire right, title and interest in and to said patent and the design covered thereby.


AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute any agreement in conflict herewith;


