WHEREAS I, **MICHAEL GALLERT**, a German citizen, residing at Stuttgart, Germany, have invented certain new and ornamental improvements in an

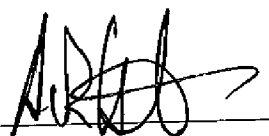
AUTOMOBILE WHEEL
