ASSIGNMENT

I hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue all Letters Patent based on said application and all said divisions, continuations, continuations-in-part, reissues, renewals and extensions to said ASSIGNEES, their successors and assigns.
