Whereas, I, Anthony J. O'Lenick, Jr. of Dacula, Ga, hereinafter referred to as patentee did obtain a United States Patent for



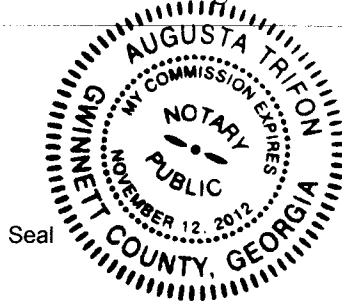

