AND I HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all such Letters Patent to the said COMPONENT HARDWARE GROUP, INC. in accordance with this instrument of Assignment.

I FURTHER covenant and agree, in consideration of the premises, that I or my executors and




