Assignors hereby request that said Design Patent be issued in accordance with this assignment.

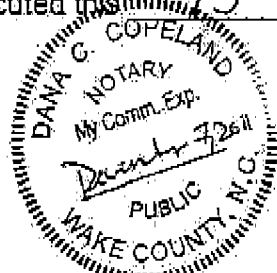

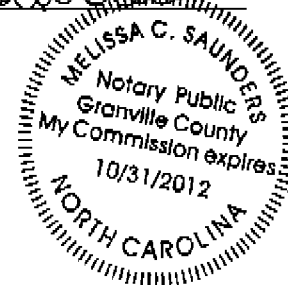


