patent protection for the Invention in all countries including assisting with the preparation of any application relating to the Invention;

ASSIGNOR does covenant and agree not to contest the validity or enforceability of any intellectual property rights assigned herein, or to assist, or request, any third party to contest the validity or enforceability of any intellectual property rights assigned herein;

ASSIGNOR does hereby release and forever discharge ASSIGNEE from any and all claims, including but not limited to any debts, liabilities, damages and causes of action of whatsoever kind or nature relating to the Invention, whether or not known, suspected and unsuspected, including any and all previous agreements entered into, which now exist, or may have existed prior to the date of this assignment.

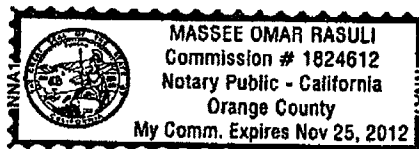
