ASSIGNOR hereby consents and agrees that a copy of this assignment agreement shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document that may be required in any particular country for any purpose and, more particularly, in proof of the right of ASSIGNEE to claim the aforesaid benefit of the right of priority.

ASSIGNOR covenants and agrees that this Assignment and all the terms thereof shall inure to the benefit of the successors, assigns, legal representatives, or nominees of ASSIGNEE, without further written or oral authorization from ASSIGNOR.
