Confirmatory Assignment of Patent Rights

This Confirmatory Patent Assignment (this "Confirmatory Assignment") is by and between Genentech, Inc., a Delaware corporation, with offices at 1 DNA Way, South San Francisco, CA 94080-4990 ("GENENTECH") and Curis Inc., a Delaware corporation, with offices at 45 Moulton Street, Cambridge, MA 02138 ("CURIS").

WHEREAS, the parties to this Confirmatory Assignment have entered into a certain Collaborative Research, Development and License Agreement, dated June 11, 2003, as amended and restated by the parties from time to time (the "Collaboration Agreement"), pursuant to which the parties engaged in certain research, discovery and development activities relating to the Hedgehog Pathway (as defined in the Collaboration Agreement);

WHEREAS, U.S. Provisional Application Serial No. 60/607,367 entitled PYRIDYL INHIBITORS OF HEDGEHOG SIGNALLING was filed in the United States Patent and Trademark Office on September 2, 2004 (the "'367 Application") and U.S. Non-Provisional Application Serial No. 11/217,663 was filed in the U.S. Patent and Trademark Office on September 2, 2005 (the "'663 Application") (collectively, the "Applications"); and

WHEREAS, assignments of the '367 Application and the '663 Application were recorded on November 30, 2005 at reel/frame 017265/0435, and on March 5, 2007, at reel/frame 018957/0519, respectively, pursuant to which the parties intended that GENENTECH and CURIS be joint owners of the entire right, title, and interest in and to the Applications and inventions described therein, and any and all U.S. and foreign divisions and continuations thereof, and any and all Letters Patent (U.S. and foreign) which may be granted thereon, including any and all renewals, reissues, reexaminations and extensions thereof.

NOW, WITNESSETH that for good and valuable consideration, the receipt of which is hereby acknowledged, GENENTECH and CURIS hereby confirm that, by assignment from the inventors of the Applications, they are the joint owners of the entire right, title, and interest in and to the Applications and inventions described therein, and any and all U.S. and foreign divisions and continuations thereof, and any and all Letters Patent (U.S. and foreign) which may be granted thereon, including any and all renewals, reissues, reexaminations and extensions thereof.
