## ASSIGNMENT OF PATENT APPLICATION

- 4) authorize and request the Commissioner for Patents to issue any patents granted for said improvements to the ASSIGNEE for its interest and for the sole use and benefit of its successors, legal representatives and assigns;
- 5) warrant and represent that any assignment, grant, mortgage, license, contract, or other agreements that conflicts with this assignment has not been entered, and will not be entered by the undersigned; and
- 6) authorize and request my representative, Roger H. Chu, USPTO Reg. No. 52745, to insert above the U.S. patent application serial number and the filing date in order to make this assignment suitable for recordation in the United States Patent and Trademark Office and any Patent Offices foreign to the United States.
