AND Assignor hereby authorizes and requests the appropriate governmental officials to issue any and all patents under said Invention, or resulting from U.S. Application No. 29/313,211, and any and all reissues, divisions, continuations, continuations-in-part, renewals, substitutes or extensions thereof, to the Assignee, as the assignee of the entire right, title and interest in and to the same;

AND Assignor hereby represents, warrants and covenants that he has the full right to convey the entire interest herein assigned, that he has not executed and will not execute any instrument or assignment in conflict herewith, and that the rights assigned herein are not otherwise encumbered by any grant, license or right;


