CHANGE OF NAME



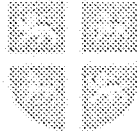
