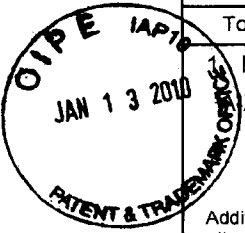

INTELLECTUAL PROPERTY PURCHASE AGREEMENT

This INTELLECTUAL PROPERTY PURCHASE AGREEMENT (this "Agreement") is made and entered into this 9 day of May, 2005, by and between:

- (1) Masanobu AIZAWA, a resident of Japan having his address at 5-10-16 Kounan, Kounan-ku, Yokohama city, Kanagawa Prefecture, Japan (the "Assignor"); and
- (2) LG.Philips LCD Co., Ltd. a corporation created and existing under the laws of Korea and having the address at 20 Yeido-Dong, Youngdeungpo-Gu, Seoul, Korea 150-721 (the "Assignee").

(Each of the Assignor and the Assignee shall individually be referred to as a "Party" and collectively as the "Parties")

WHEREAS, the Assignor currently holds all rights, title and interest in and to the patents and/ or patent application identified in Exhibit A ("Subject Patent(s)") attached hereto and all foreign patents and patent application filing related hereto and all inventions and technology embodied therein;

WHEREAS, the Assignee wishes to obtain all such rights, title and interest in and to the patents and/ or patent application identified in Exhibit A and technology embodied therein; and

WHEREAS, the Assignor is willing to assign all such rights, title and interest in and to the patents and/ or patent applications identified in Exhibit A and technology embodied therein to the Assignee pursuant to the terms of this Agreement.

NOW, THEREFORE, in consideration of the foregoing and the representations, warranties, covenants and agreements herein contained, the receipt and adequacy of which are hereby acknowledged, the Parties hereto agree as follows:

1 Purchase and Sale

- 1.1 On the terms and subject to the conditions of this Agreement, the Assignor shall convey, transfer, assign and deliver to the Assignee, and the Assignee shall purchase and accept from the Assignor, at closing, all right, title and interest of the Assignor in and to those patents and applications listed in Exhibit A attached hereto and made a part hereof (hereinafter referred to as the "Subject Patents"), including, without limitation, the inventions, technology and improvements described and claimed therein and related thereto, and (a) any and all patents corresponding thereto granted in any country around the world, (b) all divisions, continuations, reissues, continuation-in-part and extensions thereof, (c) all income,

royalties, damages, payments now and hereafter due and/ or payable under and with respect thereto, including, without limitation, all rights to profits, damages and other remedies for any past, present and future infringement of such patents, and (d) all rights corresponding thereto throughout the world. The Assignor shall execute assignments of the patents substantially in the form set for in Exhibit B.

1.2 The Assignor shall assign all of his rights to file divisional patent applications from the Subject Patent, to file PCT applications claiming priority on the Subject Patent, and to file patent applications in the countries other than Japan claiming priority on the Subject Patent according to the Paris Convention.

2 Payments to the Assignor

2.1 In consideration of the Assignor's sale and assignment of the above-described Subject Patents, the Assignee shall pay a lump sum of REDACTED REDACTED to the Assignor as remuneration ("Remuneration").
