ARTICLES OF AMENDMENT  
TO THE

AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF ONTELA, INC.

Ontela, Inc., a corporation organized and existing under and by virtue of the Washington Business Corporation Action (the "**Company**"), does hereby certify:

**FIRST:** That the Company's Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Washington on December 21, 2009.

**SECOND:** This amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

**THIRD:** That Article I of the Company's Amended and Restated Articles of Incorporation (the "**Restated Certificate**") is hereby amended to read in its entirety as follows:

**"ARTICLE I.**

The name of this Corporation is Photobucket Corporation (the "Corporation")."

**THIRD:** That, by written consent of the Board of Directors of the Company on December 21, 2009, the Board of Directors adopted resolutions setting forth the proposed amendment to the Amended and Restated Articles of Incorporation of the Company in accordance with the provisions of Section 23B.10.020 of the Washington Business Corporation Act. The shareholders of the Company approved the proposed amendment on December 21, 2009.
