## ASSIGNMENT

WHEREAS, we, Nicholas Frame, of Vista, California, Chris Schartiger, of San Diego, California, and Michael Walker, of Vista, California, have invented a certain invention as described in the following patent application:

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc..

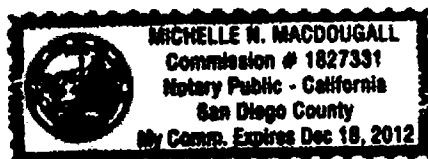

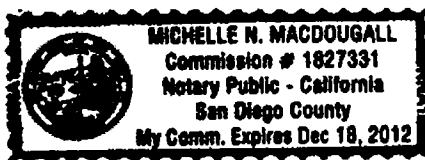


