And the Assignor hereby covenants that he/she/it has the full right to convey the interest assigned by this Assignment, and has not executed and will not execute any agreement in conflict with this Assignment;

And the Assignor and the Assignee hereby authorize the firm of Gowling Lafleur Henderson LLP, whose full post office address is 160 Elgin Street, Suite 2600, Ottawa, Ontario K1P 1C3, Canada, to correct errors in this Assignment, or to insert any further identification or other information necessary or desirable to make this Assignment suitable for recordal in any Patent Office.






