TURBINE DISK SLOT BOTTOM MACHINING

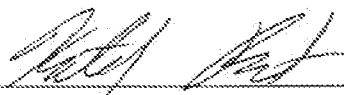

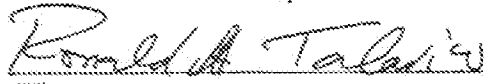
