ASSIGNMENT

FURTHER, Assignor agrees to communicate to said Assignee or its representatives any facts known to Assignor respecting said Patent Rights, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patents to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said Patent Rights in the United States and in any and all foreign countries.
