### ASSIGNMENT OF PATENT APPLICATION RIGHTS

Such right, title and interest shall be held and enjoyed by Aquasyn, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Marcilese if this assignment and sale had not been made.

Marcilese further hereby sells and assigns to Aquasyn its foreign rights to said inventions in all patent granting countries of the world, including, without limitation, the right to file applications or to obtain patents for said inventions in its own name in said countries under the terms of the Paris Convention for the Protection of Intellectual Property, together with all rights of priority and all other rights Marcilese under any and all international agreements to which the United States adheres. Marcilese hereby authorizes and requests any official, whose duty it is to issue in any country a patent or patents on said inventions or improvements, to issue patent or patents to Aquasyn or its nominees, successors or assigns.



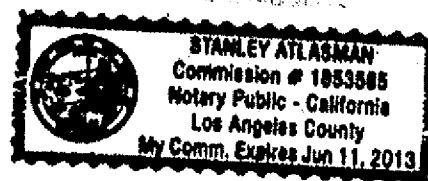
