## ASSIGNMENT OF INVENTION AND OF LETTERS PATENT

WHEREAS G. S. Blodgett Corporation (hereinafter referred to as "ASSIGNOR"), a corporation organized and existing under the laws of the State of VERMONT and having a place of business at 44 Lakeside Avenue, Burlington, Vermont 05401, is the owner of certain right, title and interest in and to certain improvements in a SELF-CLEANING CONVECTION OVEN, filed as United States Patent Application Serial No. 61/095,044 on September 8, 2008;

agrees that KFC Corporation may apply for foreign Letters Patent on the invention, and ASSIGNOR agrees to cooperate with KFC Corporation and to execute without additional consideration any additional documents as deemed necessary by KFC Corporation to apply for or maintain patents or other legal protection for the invention in any country of the world.
