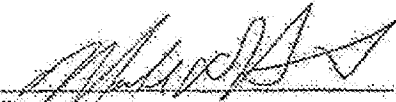
ASSIGNMENT

LAST WILL AND TESTAMENT

THIS IS THE LAST WILL AND TESTAMENT of me, STUART GARDNER MOORE, Businessman, presently of 505 Upper Bayview Road, P.O. Box 338, Lions Bay, in the Province of British Columbia VON 2B0, dated this 7th day of November, 2002.

1. I REVOKE all former Wills and Codicils made by me.

2. I APPOINT my wife, SANDRA DOROTHY MOORE, of 505 Upper Bayview Road, P.O. Box 338, Lions Bay, in the Province of British Columbia VON 2B0, to be the Executrix and Trustee of this my Will, but if she should predecease me or within a period of thirty (30) days following my death, die or be unable or unwilling to accept such appointment, I APPOINT my Grand, MICHAEL DAVID HURST, and my Bank Manager, JOHN DESANTIS, to be the Executors and Trustees of this my Will in the place and stead of my said wife. I DECLARE that in this my Will the term "Trustee" and all references thereto shall (where the context so permits) mean and include the Executrix or Executors and Trustee or Trustees for the time being hereof (whether original or substituted) and shall be construed accordingly.

3. I GIVE all my property to my Trustee upon the following trusts, namely:

- (a) To pay out of my general estate all my just debts, funeral and testamentary expenses as soon as may be convenient after my death.
- (b) To transfer and deliver all of my interest in the ALGOS (Automatic Lumber Grading Inspection System) and any and all United States and Canadian Patents relative thereto to my wife, SANDRA DOROTHY MOORE, if she survives me for a period exceeding thirty (30) days following my death for her own use absolutely.

(c) To pay the sum of Ten Thousand Dollars (\$10,000.00) to my estranged son, CHRISTOPHER MORGAN MOORE, if he survives me, for his own use absolutely. I have not made my said son a larger beneficiary of this my Will because I feel that my obligations to my wife, SANDRA DOROTHY MOORE, are greater than to my son, and because I had no contact with him from the time he was four (4) years old until he was thirty-two (32) years of age. He then became part of our lives for two (2) years and then disappeared and has not had any contact with me since then.

(d) To pay or transfer the residue of my estate to my wife, SANDRA DOROTHY MOORE, if she survives me for a period exceeding thirty (30) days following my death for her own use absolutely.

(e) If my said wife should predecease me or die within a period of thirty (30) days following my death, to pay ONE-FIFTH (1/5) of the residue of my estate then remaining to my son, CHRISTOPHER MORGAN MOORE, if he survives me, for his own use absolutely.

(f) To divide the residue of my estate then remaining equally among the following persons: my sister-in-law, JEAN KENNEDY, my niece, JOANNE KENNEDY, my nephew, MICHAEL KENNEDY, and my nephew, JONATHAN KENNEDY, all presently of Ballymena, Northern Ireland, if they survive me, for their own use absolutely, with the survivor to take all if only one shall survive me.

4. IF ANY PERSON should become entitled to a share in my estate before attaining the age of majority, the share of such person shall be held and kept invested by my Trustee and the income and capital or so much thereof as my Trustee, in her absolute discretion, considers necessary or advisable shall be used for the benefit of such person until he or she attains the age of majority.

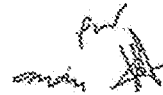

5. I AUTHORIZE my Trustee to make any payments for any person under the age of majority to a parent or guardian of such person or to anyone to whom she, in her absolute discretion, deems it advisable to make such payments, whose receipt shall be a sufficient discharge to my Trustee.

6. IT IS MY WISH AND DESIRE that my body be cremated after my death, and that my ashes be scattered over Howe Sound, with my friends and family holding an Irish style wake.

7. FOR THE PURPOSE of carrying out the provisions of this my Will and in connection with the administration of my estate, my Trustee in her absolute discretion may exercise any or all of the following powers:

- (a) To sell, call in and convert into money all the residue of my estate not consisting of money, at such time or times, in such manner and upon such terms, either for cash or credit as my Trustee shall deem advisable, with power to postpone the conversion of my estate or any part thereof until my Trustee shall deem a sale of same desirable or advantageous; and to retain any portion of my estate in the form in which it may be at my death (notwithstanding that it may be in the form of an investment in which a Trustee is not authorized to invest trust funds, and whether or not there is a liability attached to such portion of my estate) for such length of time as my Trustee in her sole discretion may deem advisable, and my Trustee shall not be held responsible for any loss that may happen to my estate by reason of her so doing;
- (b) To invest and re-invest and to vary investments without being limited to investments expressly authorized by law for trust funds;
- (c) As to any investment held by my estate to take any action or exercise any right and power that I could do if alive and the sole owner thereof;



- (d) At the expense of the capital and income (or either) of my estate to repair and improve its property;
- (e) To insure property of my estate against such risks and in such amounts as my Trustee may decide;
- (f) From time to time to borrow upon the security of all or any assets of my estate, on such terms and conditions, for such length of time and for such purposes connected to my estate as my Trustee, from time to time may think advisable;
- (g) To let, lease, mortgage, sell and convey any real estate with the same power and authority as I would personally have with respect thereto if living;
- (h) To delegate when she considers necessary any other powers, duties or discretions as she thinks fit;
- (i) To appropriate in specie or in its then actual state of investment any part of my estate in or towards the satisfaction of the share of any beneficiary hereunder, and to make any division of my estate or set aside or pay any share or benefit therein, either wholly or in part in the assets forming my estate in specie or otherwise, and for such purpose to value my estate or any part thereof and such appropriation and valuation shall be conclusive and binding on all persons interested hereunder;
- (j) In relation to taxation, to exercise at my Trustee's discretion any and all ELECTIONS permitted under the *Income Tax Act* of Canada as from time to time amended and to take all other action which may be available from time to time under all applicable law in order to minimize the taxation resulting to or from my estate.
