ASSIGNOR does also hereby assign and transfer unto the ASSIGNEE, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the Patent, the right to sue for and collect the same for its own use and for the use and enjoyment of its successors, legal representatives or other assigns.

And ASSIGNOR further agrees to execute and deliver at the request of the ASSIGNEE, all papers, documents, instruments and assignments, and to perform any other reasonable acts, at ASSIGNEE's sole cost and expense, that (1) the ASSIGNEE may require in order to vest all of ASSIGNOR's rights, title and interest in and to the Patents in the ASSIGNEE; (2) may be required in states and countries foreign to the United States to record ASSIGNEE as the owner of the Patent herein assigned; and (3) the ASSIGNEE may require in any legal action that ASSIGNEE may take regarding the protection of the rights of the ASSIGNEE in the Patent.

And ASSIGNOR further agrees to provide evidence to support any of the foregoing in the event such evidence is deemed necessary to the ASSIGNEE, to the extent such evidence is in the possession or control of the ASSIGNOR.

And ASSIGNOR further authorizes the Commissioner of the Patents and Trademarks of the United States, and any official of any state or country foreign to the United States, whose duty it is to record patents, applications and title thereto, to record the Patent, applications and title thereto, to record the Patent and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument.

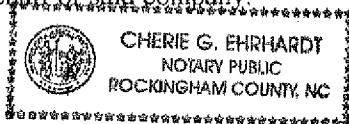
