## ASSIGNMENT

WHEREAS, NEIL PHILIP PIERCY, residing at 61 Church Street, Thriplow, Royston, Hertfordshire SG8 7RE Great Britain; AKHILESH POKHARIYAL, residing at 7 Pulteney Close, Isleworth, Middlesex, TW7 6PX Great Britain; and NICHOLAS DOUGALL JOHNSON, residing at 2238 Hyde St., Apartment 12, San Francisco, California 94109 (hereinafter referred to as Assignor), have invented certain new and useful improvements in NETWORK ELEMENT AND METHOD FOR SETTING A POWER LEVEL IN A WIRELESS COMMUNICATION SYSTEM for which an application for United States Letters Patent was executed on August 12, 2009, Appln.
