## ASSIGNMENT

Further, I hereby covenant and agree to and with Rosen Entertainment Systems, L.P., and its successors and assigns, at the time of execution and delivery of these presents, that I am the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified design patent application, and that the same are unencumbered, and that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, I agree that I will communicate to Rosen Entertainment Systems, L.P., or its representatives, any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Rosen Entertainment Systems, L.P., make all rightful oaths, and generally do everything possible to aid Rosen Entertainment Systems, L.P., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
