South Wimbrow Drive, Sebastian, Florida 32958, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **CONTINUOUS PROCESS FOR CONVERTING NATURAL GAS TO LIQUID HYDROCARBONS**, filed February 5, 2007, Application No. 11/703,358, together with claim to the priority of United States Provisional Application No. 60/765,115, filed February 3, 2006.
