## ASSIGNMENT

IN CONSIDERATION of One Dollar (\$1.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, said GIANCARLO PIRETTI, hereby sells, assigns and transfers to said PRO-CORD S.p.A., its successors and assigns, the entire right, title and interest in:

**NESTABLE CHAIR WITH SEAT ROTATION AND STOP ARRANGEMENT**  
and the invention therein as set forth in his application for United States Letters Patent therefor, executed on even date herewith, and in and to said application and any divisions or continuations thereof, and any Letters Patent obtained for the said invention in the United States and foreign countries, or issuing out of said application or any such division or continuation thereof, and any reissues or extensions of any such Letters Patent.

And, he further covenants that he will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title in said PRO-CORD S.p.A., to said invention or any Letters Patent that may be granted therefor, and that if said PRO-CORD S.p.A., or its assignee, desires to make a substitute, divisional or continuation application for said invention, or to secure a reissue or extension of said Letters Patent, to file a disclaimer relating thereto, or an application for a corresponding patent in any foreign country, that he will, upon request, sign all papers, make all rightful oaths, and do all lawful acts requisite for the said purpose, but at the expense of said PRO-CORD S.p.A.

And, he further covenants and acknowledges that the entire beneficial interest in the invention to which the above application relates is irrevocably vested in the assignee including the right to make applications for protection in all countries abroad and to claim

priority under the International Convention for such applications and hereby assent to the making of any such applications, with or without priority claim, and of any divisional applications resulting therefrom.

And, he further covenants that he will at all times, communicate to the said PRO-CORD S.p.A., its successors, assigns, or legal representatives, all facts relating to said invention and Letters Patent, or the history thereof, known to him, and testify as to the same in interferences or other litigation when requested so to do.
