Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in my name or in the name of Assignee or otherwise as Assignee may deem advisable, in the United States or internationally, whether filed directly or under any international treaty of convention (including the Patent Cooperation Treaty and Paris Convention);

3. 
