AND I, the Assignor, hereby affirm that my title in and to the invention and the application hereby conveyed is free from any and all outstanding licenses or adverse rights and I hereby covenant that I will, for the consideration aforesaid, hereafter execute any and all lawful documents and papers which may be necessary to completely vest the title to the invention to the the application in the United States of America, to the International Patent Cooperation Treaty application, to any foreign patent application or registered design application, to any patent issuing on any such application and to any continuation, renewal, division, reissue or reexamination of the application or patents, in the Assignee, its successors or assigns.


AND I, the Assignor, hereby request and authorize the Commissioner of Patents and Trademarks to issue the Letters Patent of the United States of America which may be granted on the application to the Assignee, its successors and assigns.
