ASSIGNMENT

WHEREAS, I, Bryan L. NOW, THEREFORE, for a valuable consideration, the receipt of which ASSIGNOR acknowledges, ASSIGNOR has sold, assigned, transferred and set over, and does hereby sell, assign, transfer, and set over to ASSIGNEE the entire right, title, and interest in said applications and said invention, and in any and all United States Letters Patents that have been or may be granted and issued therefor and all continuations, divisionals, continuations-in-part, reissues, and extensions thereof, and all priority rights under the Patent Cooperation Treaty and the Paris Convention for the Protection of Industrial Property for every member country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said invention in any foreign countries and all patents (including all continuations, divisionals, continuations-in-part, extensions, renewals and reissues thereof) granted for said invention in any foreign countries; and ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patent registrations, certificates and the like for said invention to ASSIGNEE in accordance with the terms of this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

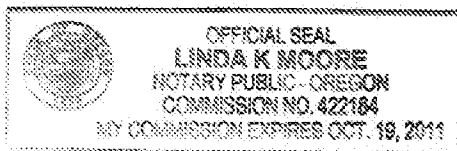
