And Assignor further covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this Assignment;

And Assignor further covenants that Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to the Patent as may be known and accessible to Assignor, and Assignor will testify to the same in any interference or litigation related thereto and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments, declarations, or affidavits required to apply for, obtain, maintain, and enforce the Patent which may be necessary or desirable to carry out the purposes hereof.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
