Each of the undersigned also hereby appoints ASSIGNEE as its common agent for purposes of prosecuting international patent applications and any material patent applications for which such common agency is recognized.

Hereby requests the Honorable Director of the United States Patent and Trademark Office to issue said Letters Patent to said ASSIGNEE.


