Pursuant to the provisions of the Washington Business Corporations Act, Chapter 23B.10 RCW, the following Articles of Amendment to Articles of Incorporation are submitted for filing.

1. The name of record of the corporation is STEVEN SIMS, INC.
2. The amendments to the Articles of Incorporation as adopted are as follows:

Article I of the Articles of Incorporation, dated July 17, 1991, shall be amended as follows:

ARTICLE I


The name of the corporation shall be **SIMS VIBRATION LABORATORY, INC.**

3. The amendment provides for no exchange, classification, or cancellation of issued shares.
