



FURTHER, we agree that we will communicate to said Carlisle FoodService Products, Incorporated, or its representatives, any facts known to us respecting said invention, and testify in

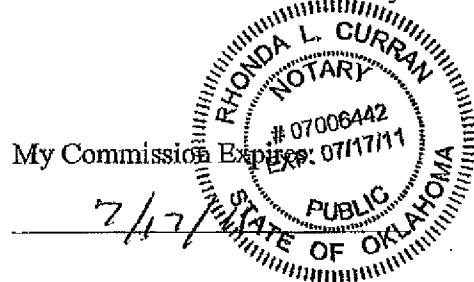



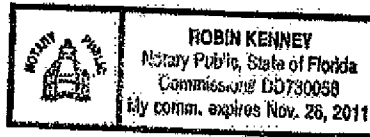
