AFFIDAVIT


The undersigned, being duly sworn, hereby deposes and says under oath as follows:

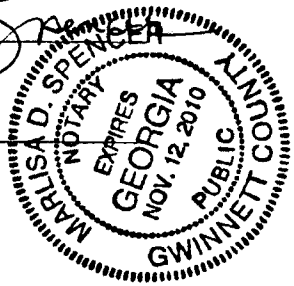
