ASSIGNMENT

WHEREAS, **Rembrandt Enterprises, Inc.**, an Iowa corporation whose mailing address is 1419 480th Street, Rembrandt, IA 50576 (hereinafter "Rembrandt"), is an alleged owner of U.S. Patent Application Serial No. 10/800,578 filed March 15, 2004 (abandoned), U.S. Patent Application Serial No. 10/800,577 filed March 15, 2004, U.S. Patent Application Serial No.: 12/210,436 filed September 15, 2008 and Canadian Patent Application No. 2,500,125, filed March 10, 2005 (collectively, the "Patents"), all by virtue of an Assignment from Golden Oval Eggs, LLC (Golden Oval) to Rembrandt erroneously executed and recorded in the U.S. Patent Office.

AND WHEREAS, **Michael Foods, Inc.** a Delaware corporation with a principal place of business at 301 Carlson Parkway, Suite 400, Minnetonka, MN 55402 (hereinafter "Michael Foods") is the current owner of the Patents and is desirous of acquiring the entire right, title and interest in the Patents;

NOW THEREFORE, be it known that Rembrandt, as Assignee of Golden Oval's interests in an "Assignment and License Agreement" between Golden Oval and Michael Foods, Inc. dated March 1, 2009 and to correct the erroneous Assignment of the Patents that are the subject of the "Assignment and License Agreement" between Golden Oval and Michael Foods, for good and valuable consideration does hereby sell, assign, transfer and set over, unto Michael Foods all of the Rembrandt's right, title and interest in the Patents as if the Assignment from Golden Oval to Rembrandt had not occurred and with Rembrandt now standing as an Assignee of Golden Oval's interests under the Assignment and License Agreement between Golden Oval and Michael Foods.

Rembrandt further covenants that it will, upon request to it, but without expense to it, do all other lawful acts necessary to enable Michael Foods to obtain, maintain, and enforce full benefits from and record the assignment to it of the rights and interests in the Patents herein assigned.

This Assignment shall be binding upon the successors and assigns of Rembrandt and shall inure to the benefit of the successors and assigns of Michael Foods.
