PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of March 5, 2010, by CHURCHILL FINANCIAL LLC (“Churchill”).

WITNESSETH:

WHEREAS, CHURCHILL and BLUE RIBBON BAKING, INC., now known as BUENA VISTA FOOD PRODUCTS, INC., a California corporation (“Grantor”), were parties to that certain Patent Security Agreement, dated as of December 30, 2008 (the “Assignment”), pursuant to which Grantor granted a security interest to Churchill in certain patents (the “Patents”) and Patent Rights (as defined below) as security for certain obligations owing by Grantor to Churchill, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Patent Division of the United States Patent and Trademark Office on December 31, 2008, at Reel 022043, Frame 0454; and

WHEREAS, Grantor has requested that Churchill release its security interest in the Patents and Patent Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Churchill hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Patent Rights**”):

(i) each Patent and application for Patent listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.

2. Churchill hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Churchill, all of Churchill’s right, title and interest in and to the Patents and the Patent Rights.
