WHEREAS, I, the undersigned, have invented certain new and useful improvements in the following:

SINGLE OPTIC ACCOMMODATIVE INTRAOCULAR LENS SYSTEM

for which I have made application for United States Letters Patent.

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

We hereby further agree that I will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

We further authorize and direct Alcon attorneys to insert below* the serial number and filing date of said application now identified as Attorney Docket No. 3560 as soon as the same shall have been made known to them by the United States Patent Office.




