ASSIGNMENT

WHEREAS, ROBERT BOSCH GMBH, Postfach 10 60 50, 70049 Stuttgart, GERMANY (hereinafter referred to as Assignor), is the sole owner of certain below-identified United States intellectual-property rights, and

- (4) Any other United States patent or United States patent application claiming common priority with the '339 patent, the '520 patent, or the '100 application and any resulting United State patent, or which is the subject of a terminal disclaimer involving the '339 patent, the '520 patent, or the '100 application and any resulting United State patent; including the entire United States right, title and interest in and to the inventions, improvements and discoveries disclosed in the above-described United States patents and patent applications; all other United States patent applications and any corresponding United States patent rights which have been or shall be filed on any of the inventions, improvements and discoveries disclosed or claimed in the above-described United States patents and patent applications; all regular patent applications, continuations, divisions, and reissues thereof; all rights of priority and the right to file and to prosecute such applications; and further including the right to sue and collect damages for all past, current, and future infringements of the above-described United States patents and patent applications; the same to be held and enjoyed by the said Assignee for its own use and behalf, and for its legal representatives and assigns, to the full end of the term for which said patents have been or shall be granted, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made.

Assignor also authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to transfer said United States Patents and Application to

Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.
