ASSIGNOR agrees that when requested by ASSIGNEE, it will execute all documents necessary or desirable to properly vest full right, title, and interest in and to all PATENT RIGHTS throughout the world in the name of ASSIGNEE or that, in the sole judgment of ASSIGNEE, may be necessary to obtain, maintain, issue, or enforce said PATENT RIGHTS.

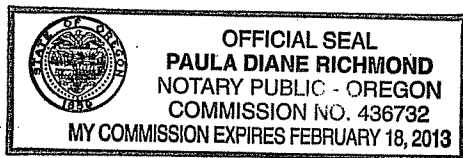
