## PATENT ASSIGNMENT

Assignor further agrees that should additional acts or further documentation of the assignment be required to protect, secure, vest and record good title to the Assigned Patents in Assignee, Assignor will, without further consideration, obtain, provide or execute such other information or documents or perform such acts as may be reasonably necessary upon Assignee's request.
3. Assignor hereby authorizes and requests the Commissioner for Patents of the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Assigned Patents registered in the corresponding jurisdiction.
4. This Patent Assignment may be executed in one or more counterparts, each of which will be deemed an original and all of which together will constitute the same instrument.

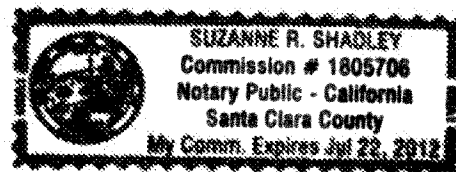
