**CONFIRMATORY ASSIGNMENT OF REGISTERED
INTELLECTUAL PROPERTY RIGHTS AND
APPLICATIONS FOR REGISTERED INTELLECTUAL
PROPERTY RIGHTS**

- (1) VECTURA LIMITED
- (2) VECTURA DELIVERY DEVICES LIMITED

THIS DEED OF CONFIRMATORY ASSIGNMENT is made on 4 March 2010

BETWEEN:-

- (1) **VECTURA LIMITED**, a company registered in England under company registration number 01696917 whose registered office is at 1 Prospect West, Chippenham, Wiltshire, SN14 6FH, United Kingdom, (the "**Assignor**"); and
- (2) **VECTURA DELIVERY DEVICES LIMITED**, a company registered in England under company registration number 04026469 whose registered office is at 1 Prospect West, Chippenham, Wiltshire, SN14 6FH, United Kingdom, (the "**Assignee**").

WHEREAS:

- (A) Pursuant to and under a deed of assignment agreement effective 4 December 2009 between the Assignor and the Assignee, the Assignor assigned, and the Assignee acquired certain registered design rights and unregistered design rights in the same.
- (B) The Assignor is the registered proprietor of various registered intellectual property rights identified in the Schedule 1A (the "**Registered Rights**") and various applications for registered intellectual property rights also identified in the Schedule 1B (the "**Applications**") (collectively the Registered Rights and Applications referred to as the "**Rights**").
- (C) The Assignor wishes to confirm the assignment of the Assignor's right, title and interest in the Rights to the Assignee which was effective as of 4 December 2009, and the Assignee wishes to confirm receipt of the assignment of the Assignor's right, title and interest in the Rights effective as of 4 December 2009, in accordance with the provisions of this Assignment.

THE DEED OF ASSIGNMENT WITNESSES AS FOLLOWS:

1. Assignment

- 1.1. The Assignor hereby confirms assignment, effective as of 4 December 2009, to the Assignee irrevocably and unconditionally, all of the Assignor's right, title and interest in the Rights, including, but not limited to:-
 - 1.1.1. the full and exclusive benefit of each of the Rights and all rights, privileges and advantages associated with each of them throughout the world and for their full term;
 - 1.1.2. the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise, in relation to infringements of the Registered Rights, including, without limitation, any intellectual property rights resulting from any of the Applications, together in each case with all accrued rights of action, the right to recover damages for past infringements and the right to obtain injunctive or other relief in relation to each of the Rights;

- 1.1.3. the right to apply for and the right to be granted registered intellectual property rights or other rights and protection anywhere in the world in respect of (i) any of the Applications; and, (ii) any of the inventions, concepts or designs disclosed in any of the Rights;
- 1.1.4. all rights to claim priority anywhere in the world on the basis of any of the Rights and any priority applications in respect of any of the Rights; and
- 1.1.5. the right to apply for extensions and renewals in respect of any of the Rights including, without limitation, any registered intellectual property rights resulting from any of the Applications.

2. Covenants

2.1. The Assignor covenants that at the date of this Assignment:-

- 2.1.1. the Rights are subsisting and all patent office or registry fees payable in respect of the Rights at the date of this Assignment have been paid in full;
- 2.1.2. the Assignor is the registered proprietor of the Rights.

3. Further Assurances

- 3.1. The Assignor shall free of charge, as and when requested by the Assignee, do all acts and execute all documents as may be reasonably necessary or desirable to give full effect to the provisions of this Assignment and/or to enable this Assignment to be registered with each applicable patent office, intellectual property office or registry of any territory concerned with each and any of the Rights.

4. Law

- 4.1. This Assignment shall be governed by English Law.
