**Worldwide Assignment of Patent Rights**

NOW, THEREFORE, in consideration of the sum of: Twenty Thousand US dollars (US\$20,000), the receipt whereof is acknowledged, I, the lawful Patentee, by these presents do SELL, ASSIGN and TRANSFER unto said ASSIGNEE, the full and exclusive worldwide right, title and ownership interest in the above Patents and Patent Applications and all right, title, and interest in and to any division, substitution, continuation, continuation-in-part, continued prosecution, or other patent application(s) thereof filed in the United States, under international treaty or agreement, or in any foreign country or region, and all patents, utility models, inventor's certificates, or other similar rights which may be granted thereon and any reissues or extensions thereof ("Inventions") and any and all patents, patent applications, or other information whether previously or subsequently made by me or acquired by me based upon or derived from the Patents and Patent Applications (the "Improvements") and all worldwide rights to make, use, offer for sale and sell products which incorporate the Inventions and Improvements and all federal, state, foreign, statutory and common law and other rights in the Trademarks and all goodwill therein, along with all rights to causes of action and remedies related to the Inventions and Improvements, and Trademarks including, without limitation, the right to sue for past, present or future infringement, misappropriation or violation of rights related to the forgoing; and any and all other rights and interests arising out of or in connection with the Inventions and Improvements and Trademarks.

I hereby authorize and request the USPTO as well as all appropriate patent offices of countries foreign to the United States, to issue any and all such Patent(s) granted on such Inventions and Improvements to said ASSIGNEE as having the entire right, title, and interest in and to said Inventions and Improvements, for its sole use and benefit, and for the use and benefit of

its legal representatives for the full extent of the term for which said Patent(s) and Patent Application(s) may be granted.

I warrant and covenant that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others by the undersigned, and that the full right to convey the same as herein expressed is solely possessed by the undersigned.





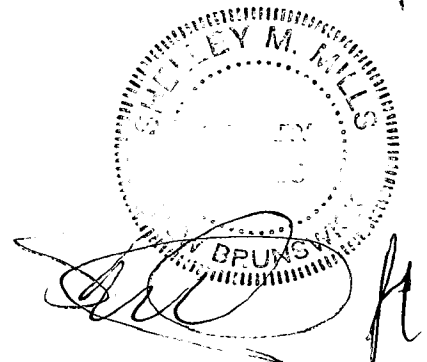
