PATENT ASSIGNMENT

This Agreement is made between AIRGIZMOS, GP, LLC, (formerly AIRGIZMOS, LLC) a Texas limited liability company, registered to do business in Texas, with an address at 2080 Campbell Creek Blvd., Suite 300, Richardson, TX 75082 (the "Company") on one side, and AIRGIZMOS, LP, a Texas limited partnership, registered to do business in Texas, with an address at 2080 Campbell Creek Blvd., Suite 300, Richardson, TX 75082 (the "Assignee") on the other side.

WITNESSETH:

WHEREAS, AIRGIZMOS, LLC changed its name to AIRGIZMOS, GP, LLC on November 23, 2009; and

WHEREAS, the Company invented an aircraft control surface gust lock, (the "Invention"); and

WHEREAS, the Company filed a U.S. utility patent application for the Invention, entitled "*Aircraft Control Surface Gust Lock*," Application Serial No. 12/180,349 (the "Patent Application"), filed on July 25, 2008; and

WHEREAS, the Company is desirous of assigning all of its rights, including patent rights, to the Invention and the Patent Application and any patents that may issue therefrom (the "Patents"); and

WHEREAS, the Assignee is desirous of obtaining the Company's rights in the Invention, the Patent Application, and Patents, taking over prosecution of the Patent Application, and enforcing any patent rights that may issue therefrom.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee and the Company agree as follows.

1. The Company hereby assigns without limitation to the Assignee for the territory of the United States of America and the entire world, their entire right, title, and interest in and to the Invention, the Patent Application, and the Patents, including all divisionals, continuations, continuations-in-part, renewals, reissues, or substitute applications, and also including all priority rights for patent applications foreign to the United States of America. The Company hereby transfers and conveys to the Assignee the right to recover for any past, present, and future infringement of the Patents assigned herein.

2. The Company hereby covenants and agrees, for itself and its legal representatives, that they will:

- (a) assist the Assignee in the prosecution of the Patent Application;
- (b) assist in the making and prosecuting of any other applications for patents that the Assignee may elect to make covering the Invention, including any applications for reissue, applications for reexamination, and applications for foreign patent rights;
- (c) assist in any proceedings in the United States Patent and Trademark Office affecting the Invention;
- (d) invest in the Assignee exclusive title in and to all such other applications and patents claiming priority through the Patent Application;
- (e) assist in the prosecution of any interferences, which may arise involving the Invention, or any applications or patents herein contemplated;
- (f) promptly execute and deliver to the Assignee any and all additional papers and make all lawful oaths, which may be requested by the Assignee to fully carry out the terms of this Patent Assignment;
- (g) communicate to the Assignee, or to its successors, assigns, and legal representatives, any facts known respecting the Invention;
- (h) at the expense of the Assignee, testify in any legal proceedings; and
- (i) generally do everything possible to aid the Assignee, its successors, assigns, and nominees, to obtain and enforce proper patent protection for the Invention in all countries.




