for which an application is about to be made for Letters Patent of the United States, said application having been executed on even date herewith; and

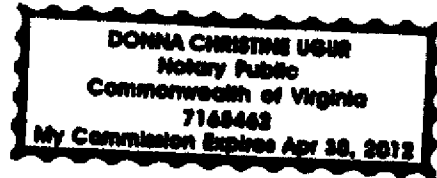




