CONFIRMATION OF ASSIGNMENT OF IP RIGHTS

THIS DEED is made on ~~November~~ ^{DECEMBER} 15, 2009

PARTIES

1. **James Hardie International Finance B.V.**, a private limited liability company (*besloten vennootschap met beperkte aansprakelijkheid*) organized and existing under the laws of The Netherlands, with Ministry of Justice number B.V. 1000894, having its corporate seat in Amsterdam, The Netherlands, with address Strawinskylaan 3077, 1077 ZX Amsterdam, The Netherlands, registered with the Amsterdam trade register under number 34108775 (**Assignor**); and
2. **James Hardie Technology Limited**, a corporation organized and existing under the laws of Bermuda, having its registered office at Clarendon House, 2 Church Street, Hamilton, HM 11, Bermuda, with address at Europa House, Second Floor, Harcourt Centre, Harcourt Street, Dublin 2, Ireland registered with the Bermuda trade register under number EC 43298 (**Assignee**).

RECITALS

- A. The Assignor is the owner of, or applicant for, the trade marks (the **Trade Marks**); (if any), the patents (the **Patents**) (if any), and the designs (the **Designs**) (if any), listed or referred to in the Schedule (IP Rights).
- B. The Assignor has assigned to the Assignee all the Assignor's right, title and interest in and to the IP Rights pursuant to a Deed of Sale, Transfer and Assignment of Intellectual Property dated 1 October 2009 (**Effective Date**).

OPERATIVE PROVISIONS

1. In consideration of the payment of US\$1 and other good and valuable consideration by the Assignee to the Assignor, the receipt and sufficiency of which is acknowledged by the Assignor, the parties confirm that the Assignor has assigned to the Assignee and the Assignee has accepted absolutely on and from the Effective Date:
 - (a) the entire right, title and interest in and to the Patents and Designs without geographical limit including the benefit of all priority rights and, in the case of the Patents, the right to file further applications based on the Patents such as but not limited to divisional, continuation and continuation-in-part applications, patents of addition and utility applications;
 - (b) all rights to register and otherwise exploit the Patents and Designs including, in the case of the Patents, all corresponding rights obtainable in respect of the inventions that are described and/or claimed in the Patents; and
 - (c) all rights, powers, liberties and immunities arising from any rights granted in relation to the Patents and Designs including the right to sue for and obtain injunctive relief, damages and all other remedies for any infringement of the assigned rights which may have occurred prior to or after the date of the assignment or this Deed.
2. In consideration of the payment of US\$1 and other good and valuable consideration by the Assignee to the Assignor, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby confirms that it has assigned to the Assignee and the Assignee has accepted to hold absolutely on and from the Effective Date all of the Assignor's rights, title and interest in and to the Trade Marks, including the goodwill relating to the Trade Marks, and including any International registrations based thereon, and any national registrations based on or derived from those International registrations.
