**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION**

JohnsonDiversey, Inc., a corporation organized and existing under the laws of the State of Delaware, does hereby certify:

1. That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board adopted at a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation:

RESOLVED, that the Certificate of Incorporation of this corporation be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

FIRST: NAME. The name of the corporation is Diversey, Inc. (the "Corporation").


