DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT is made the 27th day of January 2010.

BETWEEN:

G7TH LIMITED, a company registered in England and Wales as company number 04006037 and having its registered office at 27 Westhawe, Bretton, Peterborough, Cambridgeshire, PE3 8BA (hereafter called "Assignor") of the one part,

and

C7TH LIMITED, a company registered in England and Wales as company number 06724665 and having its registered office at 27 Westhawe, Bretton, Peterborough, Cambridgeshire, PE3 8BA (hereafter called "Assignee") of the one part,
of the other part .

WHEREAS:

- A) Assignor is the proprietor and owner of various Intellectual Property Rights including but not limited to the patent, trade marks and design rights set out in the attached schedule;
- B) "Intellectual Property Rights" means patents, trade marks, service marks, rights (registered or unregistered) in any designs, applications for any of the foregoing, trade or business names, copyright (including rights in computer software) and typography rights, rights protecting the goodwill and reputation of the Assignor, database rights and all rights and forms of protection of a similar nature to any of the foregoing and all rights under licences and consents in respect of any of the rights mentioned in this definition which are assignable to the Assignee, including but not limited to the patent, trade marks and design rights set out in the attached schedules; and

- B) Assignor and Assignee have agreed that Assignee shall acquire the Intellectual Property Rights of the Assignor including but not limited to the patent rights, trade marks rights, and design rights set out in the attached schedule, and any related accrued rights with respect to infringements (if any) thereof, and that these shall be recorded in the name of Assignee and/or the successors or assigns of Assignee.

NOW THIS DEED WITNESSETH as follows:

In pursuance of the said agreement, and in consideration of the sum of £1.00 paid by Assignee to Assignor (the receipt whereof is hereby acknowledged):

1. The Assignor does HEREBY ASSIGN to Assignee, with full title guarantee, and free from all encumbrances, all rights, title and interest in the Intellectual Property Rights including but not limited to the patent, trade marks and design rights set out in the attached schedule, and including any such corresponding related divisional, national and regional phase rights (if any) filed or to be filed, and including the right to claim priority from such rights together with all the rights and powers and liberties and immunities conferred on the proprietor thereof by the grant of Intellectual Property rights in respect thereof and including the right to sue for damages and other remedies in respect of any infringement of the rights which may have occurred prior to the date hereof, and to hold the same unto Assignee, or any assigns of the Assignee; absolutely.
2. The parties hereto hereby agree to execute and do any documents and things which may be required in due course by the relevant authorities for giving effect to this assignment in all relevant regions and states and countries.
3. This Assignment shall be governed by and construed in accordance with English law and the parties agree to submit to the non-exclusive jurisdiction of the English courts.
4. This Assignment may be executed in separate counterparts each of which when so executed and delivered shall be an original but both counterparts shall together constitute one and the same instrument.
